**AND UPON** the Court being satisfied pursuant to s12(2)(b) Human Rights Act 1998 that the Claimants had compelling reasons why the Defendants should not be notified of the Application prior to the Court hearing the Application

**AND UPON** the Court having particular regard to the importance of the Defendants' Article 10 and Article 11 Convention rights to freedom of expression and freedom of lawful assembly

**AND UPON** the Court being satisfied that the order sought does not prohibit peaceful protest

**AND UPON** the Court considering its discretion to grant injunctive relief pursuant to s.37(1) Senior Courts Act 1981 and considering it just and convenient to do so

**AND UPON** the Court accepting the undertakings given in Schedule A of this Order

## **IT IS ORDERED THAT:**

### **Definitions**

1. For the purpose of this Order:
  - 1.1 **"The Roads"** shall mean the Roads identified in Annexe 1A, 2A, 3A, 4A to this Order and to the Claim Form, as marked in purple on the maps at Annexes 1A, 2A, 3A, and 4A to this Order and to the Claim Form.
  - 1.2 **"The Aylesbury Site"** shall mean Arla Foods Limited's site at Aylesbury Dairy, Samian Way, Aston Clinton, Aylesbury HP22 5EZ, as marked in red on the plans at Annexe 1 to this Order and to the Claim Form (**"the Aylesbury Site Plan"**).
  - 1.3 **"The Oakthorpe Site"** shall mean Arla Foods Limited's site at Oakthorpe Dairy, Chequers Way, Palmers Green, London N13 6BU, as marked in red on the plans at Annexe 2 to this Order and to the Claim Form (**"the Oakthorpe Site Plan"**).
  - 1.4 **"The Hatfield Site"** shall mean Arla Foods Hatfield Limited's site at Hatfield Distribution Warehouse, 4000 Mosquito Way, Hatfield Business Park, Hatfield, Hertfordshire AL10 9US, as marked in red on the plans at Annexe 3 to this Order and to the Claim Form (**"the Hatfield Site Plan"**).
  - 1.5 **"The Stourton Site"** shall mean Arla Foods Limited's Dairy at Pontefract Road, Leeds LS10 1AX and National Distribution Centre at Leodis Way, Leeds LS10 1NN as marked in red on the plans at

Annexe 4 to this Order and to the Claim Form (“**the Stourton Site Plan**”).

## **INJUNCTION**

### **Prohibitions**

2. Until and subject to any further order of the Court, the Defendants and each of them (whether by themselves or by instructing, encouraging or allowing any other person) are forbidden from:
  - 2.1 Entering into, entering onto, tunnelling under or remaining on the following Sites:
    - (i) **The Aylesbury Site** as marked in red on the attached **Aylesbury Site Plan** at Annexe 1;
    - (ii) **The Oakthorpe Site** as marked in red on the attached **Oakthorpe Site Plan** at Annexe 2;
    - (iii) **The Hatfield Site** as marked in red on the attached **Hatfield Site Plan** at Annexe 3;
    - (iv) **The Stourton Site** as marked in red on the attached **Stourton Site Plan** at Annexe 4.
  - 2.2 Blocking, slowing down, obstructing or otherwise interfering with vehicular access to or from the highway at the following sites:
    - (i) **The Aylesbury Site** as marked in red on the attached **Aylesbury Site Plan** at Annexe 1;
    - (ii) **The Oakthorpe Site** as marked in red on the attached **Oakthorpe Site Plan** at Annexe 2;
    - (iii) **The Hatfield Site** as marked in red on the attached **Hatfield Site Plan** at Annexe 3; and
    - (iv) **The Stourton Site** as marked in red on the attached **Stourton Site Plan** at Annexe 4.
  - 2.3 Approaching, slowing down, or obstructing any vehicle on or moving along or accessing **the Roads** identified in Annexes 1A, 2A, 3A, 4A to this Order for the purpose of:
    - (i) disrupting vehicular access to or from **The Aylesbury Site, The Oakthorpe Site, The Hatfield Site, and/or The Stourton Site**; and
    - (ii) protesting.

- 2.4 Entering, climbing onto, climbing into, or climbing under any vehicle travelling to or from **The Aylesbury Site, The Oakthorpe Site, The Hatfield Site, and/or The Stourton Site**:
- (i) for the purpose of protesting; and
  - (ii) and without the permission of the registered keeper of the vehicle.
- 2.5 Affixing themselves (“locking on”) to any vehicle on, entering or exiting **The Aylesbury Site, The Oakthorpe Site, The Hatfield Site, and/or The Stourton Site** where the “locking on” is for the purpose of protesting.
- 2.6 Affixing themselves (“locking on”) or any other items to any of **the Roads** or any other person or object on, under or over **the Roads** for the purpose of:
- (i) disrupting vehicular access to or from **The Aylesbury Site, The Oakthorpe Site, The Hatfield Site, and/or The Stourton Site**; and
  - (ii) protesting.
- 2.7 Erecting any structure on **the Roads** for the purpose of:
- (i) disrupting vehicular access to or from Arla Foods Limited at **The Aylesbury Site, The Oakthorpe Site, The Hatfield Site, and/or The Stourton Site**; and
  - (ii) protesting.

#### **Alternative service**

3. Pursuant to CPR rules 6.15 and 6.27, the Claimants have permission, in addition to personal service, or in the alternative to personal service, to serve the **1<sup>st</sup> to 6<sup>th</sup> Defendants** and any further named Defendants with the Claim Form, Application for an Interim Injunction, the supporting documents relied on in this Claim, and this Order by **all** of the following methods (with paragraph 3.1 to 3.5 to be treated conjunctively):

- 3.1 **Websites:** placing a copy of the Claim Form, Application for an Interim Injunction, the supporting documents relied on in this Claim, and this Order on the First Claimant’s websites and Facebook pages; and

- 3.2 **Email:** sending a copy of this Order to Animal Rebellion and Extinction Rebellion at the following email addresses:

and providing a web link at which they can access the Claim Form, Application for an Interim Injunction, the supporting documents relied on in this Claim, and this Order; and

- 3.3 **Post:** where an address of a named Defendant is known to the Claimants, by posting a copy of this Order together with a covering letter through the letterbox of the named Defendant's address (or by leaving in a separate mailbox) with a notice affixed to the front door if necessary, drawing the recipient's attention to the fact that the package contains a court order. If the premises do not have a letterbox, or mailbox, or the package will not fit through the letterbox, a package may be left next to the front door and a notice containing this Order may be affixed to the front door marked with a notice drawing the recipient's attention to the fact that the package contains a court order and Claim Form and should be read urgently. The notices shall be given in the form set out in Schedule 1 to this Order; and
  - 3.4 **Text messages:** sending a text message to any named Defendant for whom the Claimants have a mobile telephone number, notifying them that an injunction order has been granted against them and providing a web link at which the Defendant can access the Claim Form, Application for an Interim Injunction, the supporting documents relied on in this Claim, and this Order. The notice shall be given in the form set out in Schedule 1 to this Order; and
  - 3.5 **Placing signs and/or notices:** on the perimeter of **The Aylesbury Site, The Oakthorpe Site, The Hatfield Site, and The Stourton Site** providing a web link and/or QR code at which the Claim Form, Application for an Interim Injunction, the supporting documents relied on in this Claim, and this Order; **OR**
  - 3.6 **Where requested:** the Claim Form, Application for an Interim Injunction, the supporting documents relied on in this Claim, and this Order may be served by email where the Defendant has requested that they be served by email and by sending the email to the address provided by the Defendant; **OR**
  - 3.7 **Lawyers:** By serving any solicitor acting for a Defendant who has filed a notice of acting in these proceedings.
4. The **deemed date of service** of any documents referred to in paragraph 3 above shall be the day on which service of the document or documents is completed in accordance with paragraph 3 above.
  5. The Defendants shall acknowledge service of the Claim Form 42 days after the deemed date of service and file any written evidence in support of the Defence by the same date.

### **Further directions**

6. The Defendants or any other person affected by this Order may apply to the Court at any time to vary or discharge it but if they wish to do so they must inform the Claimants' solicitors at the same time as the application is filed at court (and in any event not less than 48 hours before the hearing of any such application, not to include weekends or public holidays).
7. Any person applying to vary or discharge this Order must provide their full name and address, an address for service, and must also apply to be joined as a named defendant to the proceedings at the same time (to the extent they are not already so named).

### **Return Date Hearing**

8. The continuation on this Order shall be considered at a hearing to be conducted by MS Teams before a Judge on the 4<sup>th</sup> and 5<sup>th</sup> October 2022. Any evidence in support or opposition to the continuation of this Order shall be filed by 4pm on 17 September 2022.
9. The Claimants have permission to apply to extend or vary this Order or for further directions.
10. Costs reserved.

Pursuant to CPR r.40.7(1) this Order has effect from it is made, **being 31 August 2022**

### Effect of this Order – the Defendants

11. A Defendant who is an individual and who is ordered not to do something must not do it him or herself or in any other way nor must he/she do it through others acting on his/her behalf or on his/her instructions or with his/her encouragement.

### Interpretation of this Order

12. In this Order references to ‘the Defendant’ means any or all of them (unless expressly stated otherwise).
13. A requirement to serve on ‘Defendant’ means on each of them. However, the Order is effective against any Defendant on whom it is served in accordance with this Order.
14. An Order requiring ‘the Defendant’ not to do anything applies to all Defendants.
15. This Order contains the following schedules and annexes
  - (i) Schedule A-Undertakings;
  - (ii) Schedule B-Witness Statements;
  - (iii) Schedule 1-List of Named Defendants;
  - (iv) Schedule 2-Notices;

3. If the Court later finds that this order has caused loss to the Defendants, and decides that the Defendants should be compensated for that loss, the Claimants gives a cross-undertaking in damages limited to £50,000.
4. The Claimants undertake to serve upon any person who indicates an intention to participate in these proceedings a note of the hearing at which this Order was made.
5. The Claimants undertake to file at Court by 4pm on 1 September 2022 the second witness statement of Nicholas McQueen, which witness statement shall explain why the Application was made without even short notice to the Defendants.

- 2.5 Affixing themselves (“locking on”) to any vehicle on, entering or exiting **The Aylesbury Site, The Oakthorpe Site, The Hatfield Site, and/or The Stourton Site** where the “locking on” is for the purpose of protesting.
- 2.6 Affixing themselves (“locking on”) or any other items to any of **the Roads** or any other person or object on, under or over **the Roads** for the purpose of:
- (i) disrupting vehicular access to or from **The Aylesbury Site, The Oakthorpe Site, The Hatfield Site, and/or The Stourton Site**; and
  - (ii) protesting.
- 2.7 Erecting any structure on **the Roads** for the purpose of:
- (i) disrupting vehicular access to or from Arla Foods Limited at **The Aylesbury Site, The Oakthorpe Site, The Hatfield Site, and/or The Stourton Site**; and
  - (ii) protesting.

3. **Definitions**

  - 1.3 **“The Oakthorpe Site”** shall mean Arla Foods Limited’s site at Oakthorpe Dairy, Chequers Way, Palmers Green, London N13 6BU, as marked in red on the plans at Annexe 2 to this Order and to the Claim Form (**“the Oakthorpe Site Plan”**).

## **INJUNCTION**

### **Prohibitions**

2. Until the return date hearing and subject to any further order of the Court, the 30<sup>th</sup> and 38<sup>th</sup> to 40<sup>th</sup> Defendants and each of them (whether by themselves or by instructing, encouraging or allowing any other person) are forbidden from:

- (i) **The Aylesbury Site** as marked in red on the attached **Aylesbury Site Plan** at Annexe 1;
  - (ii) **The Oakthorpe Site** as marked in red on the attached **Oakthorpe Site Plan** at Annexe 2;
  - (iii) **The Hatfield Site** as marked in red on the attached **Hatfield Site Plan** at Annexe 3; and
  - (iv) **The Stourton Site** as marked in red on the attached **Stourton Site Plan** at Annexe 4.

  - (ii) and without the permission of the registered keeper of the vehicle.
- 2.5 Affixing themselves (“locking on”) to any vehicle on, entering or exiting **The Aylesbury Site, The Oakthorpe Site, The Hatfield Site, and/or The Stourton Site** where the “locking on” is for the purpose of protesting.
- 2.6 Affixing themselves (“locking on”) or any other items to any of **the Roads** or any other person or object on, under or over **the Roads** for the purpose of:
- (i) disrupting vehicular access to or from **The Aylesbury Site, The Oakthorpe Site, The Hatfield Site, and/or The Stourton Site**; and
  - (ii) protesting.
- 2.7 Erecting any structure on **the Roads** for the purpose of:
- (i) disrupting vehicular access to or from Arla Foods Limited at **The Aylesbury Site, The Oakthorpe Site, The Hatfield Site, and/or The Stourton Site**; and
  - (ii) protesting.

**Alternative service**

3. 18. A requirement to serve on ‘Defendant’ means on each of them. However, the Order is effective against any Defendant on whom it is served in accordance with this Order.
19. An Order requiring ‘the Defendant’ not to do anything applies to all Defendants.

**ANY OTHER PERSON WHO KNOWS OF THIS ORDER AND DOES ANYTHING WHICH HELPS OR PERMITS THE DEFENDANTS TO BREACH THE TERMS OF THIS ORDER MAY ALSO BE HELD IN CONTEMPT OF COURT AND MAY BE IMPRISONED, FINED OR HAVE THEIR ASSETS SEIZED**

**UPON** the Court considering the Claimants' Application to continue the Injunction Orders of Mr Justice Fancourt dated 4 October 2022 in relation to the 1<sup>st</sup> to 29<sup>th</sup> Defendants (inclusive) and 31<sup>st</sup> to 37<sup>th</sup> Defendants (inclusive), and 25 October 2022 in relation to the 30<sup>th</sup> Defendant and 38<sup>th</sup> to 40<sup>th</sup> Defendants (inclusive)

**AND UPON** hearing Counsel for the Claimants, Caroline Bolton and Natalie Pratt, without any attendance by the Defendants

**AND UPON** none of the named Defendants or any other person appearing at the hearing to argue against the continuation of the injunctive relief

**AND UPON** the Court reading the application and the witness statements listed in Schedule B

**AND UPON** the Court having particular regard to the importance of the Defendants' Article 10 and Article 11 Convention rights to freedom of expression and freedom of lawful assembly

**AND UPON** the Court being satisfied that the order sought does not prohibit peaceful protest

**AND UPON** the Court considering its discretion to grant injunctive relief pursuant to s.37(1) Senior Courts Act 1981 and considering it just and convenient to do so

**AND UPON** the Court accepting the undertakings given in Schedule A of this Order

## **IT IS ORDERED THAT:**

### **Definitions**

1. For the purpose of this Order:

- 1.2 **"The Aylesbury Site"** shall mean Arla Foods Limited's site at Aylesbury Dairy, Samian Way, Aston Clinton, Aylesbury HP22 5EZ, as marked in red on the plans at Annexe 1 to this Order and to the Claim Form ("**the Aylesbury Site Plan**").
- 1.3 **"The Oakthorpe Site"** shall mean Arla Foods Limited's site at Oakthorpe Dairy, Chequers Way, Palmers Green, London N13 6BU, as marked in red on the plans at Annexe 2 to this Order and to the Claim Form ("**the Oakthorpe Site Plan**").
- 1.4 **"The Hatfield Site"** shall mean Arla Foods Hatfield Limited's site at Hatfield Distribution Warehouse, 4000 Mosquito Way, Hatfield Business Park, Hatfield, Hertfordshire AL10 9US, as marked in red on the plans at Annexe 3 to this Order and to the Claim Form ("**the Hatfield Site Plan**").
- 1.5 **"The Stourton Site"** shall mean Arla Foods Limited's Dairy at Pontefract Road, Leeds LS10 1AX and National Distribution Centre at Leodis Way, Leeds LS10 1NN as marked in red on the plans at Annexe 4 to this Order and to the Claim Form ("**the Stourton Site Plan**").

## **INJUNCTION**

### **Prohibitions**

2. Until the hearing of the application for a final injunction and subject to any further order of the Court, the Defendants and each of them (whether by themselves or by instructing, encouraging or allowing any other person) are forbidden from:
  - 2.1 Entering into, entering onto, tunnelling under or remaining on the following Sites:
    - (i) **The Aylesbury Site** as marked in red on the attached **Aylesbury Site Plan** at Annexe 1;
    - (ii) **The Oakthorpe Site** as marked in red on the attached **Oakthorpe Site Plan** at Annexe 2;
    - (iii) **The Hatfield Site** as marked in red on the attached **Hatfield Site Plan** at Annexe 3;
    - (iv) **The Stourton Site** as marked in red on the attached **Stourton Site Plan** at Annexe 4.
  - 2.2 Blocking, slowing down, obstructing or otherwise interfering with vehicular access to or from the highway at the following sites:
    - (i) **The Aylesbury Site** as marked in red on the attached **Aylesbury Site Plan** at Annexe 1;
    - (ii) **The Oakthorpe Site** as marked in red on the attached **Oakthorpe Site Plan** at Annexe 2;
    - (iii) **The Hatfield Site** as marked in red on the attached **Hatfield Site Plan** at Annexe 3; and
    - (iv) **The Stourton Site** as marked in red on the attached **Stourton Site Plan** at Annexe 4.
  - 2.3 Approaching, slowing down, or obstructing any vehicle on or moving along or accessing **the Roads** identified in Annexes 1A, 2A, 3A, 4A to this Order for the purpose of:
    - (i) disrupting vehicular access to or from **The Aylesbury Site, The Oakthorpe Site, The Hatfield Site**, and/or **The Stourton Site**; and
    - (ii) protesting.
  - 2.4 Entering, climbing onto, climbing into, or climbing under any vehicle travelling to or from **The Aylesbury Site, The Oakthorpe Site, The Hatfield Site**, and/or **The Stourton Site**:



- (i) for the purpose of protesting; and
  - (ii) and without the permission of the registered keeper of the vehicle.
- 2.5 Affixing themselves (“locking on”) to any vehicle on, entering or exiting **The Aylesbury Site, The Oakthorpe Site, The Hatfield Site**, and/or **The Stourton Site** where the “locking on” is for the purpose of protesting.
- 2.6 Affixing themselves (“locking on”) or any other items to any of **the Roads** or any other person or object on, under or over **the Roads** for the purpose of:
- (i) disrupting vehicular access to or from **The Aylesbury Site, The Oakthorpe Site, The Hatfield Site**, and/or **The Stourton Site**; and
  - (ii) protesting.
- 2.7 Erecting any structure on **the Roads** for the purpose of:
- (i) disrupting vehicular access to or from Arla Foods Limited at **The Aylesbury Site, The Oakthorpe Site, The Hatfield Site**, and/or **The Stourton Site**; and
  - (ii) protesting.

### Alternative service

3. Pursuant to CPR rules 6.15 and 6.27, the Claimants have permission, in addition to personal service, or in the alternative to personal service, to serve the **1<sup>st</sup> to 40<sup>th</sup> Defendants** and any further named Defendants with the re-Amended Claim Form, Application(s) for an Interim Injunction, the supporting documents relied on in this Claim, and this Order by **all** of the following methods (with paragraph 3.1 to 3.5 to be treated conjunctively):

If the premises do not have a letterbox, or mailbox, or the package will not fit through the letterbox, a package may be left next to the front door and a notice containing this Order may be affixed to the front door marked with a notice drawing the recipient's attention to the fact that the package contains a court order and should be read urgently. The notices shall be given in the form set out in Schedule 2 to this Order; and

9. The Claimants have permission to apply to extend or vary this Order or for further directions. The Claimants must serve any such application on those Defendants (if any) who have acknowledged service and provided an address for service.

**OFFICIAL-SENSITIVE**

At around 05.45hrs on SUNDAY 4<sup>TH</sup> SEPTEMBER 2022, protesters arrived at ARLA DAIRIES, COLLEGE ROAD NORTH, AYLESBURY, on a pre-planned day of action against the production of milk and in an attempt to create a plant-based food system.

2 XPO LOGISTICS lorries were prevented from driving to the site by initially 5 protesters sat in the road on COLLEGE ROAD NORTH having come from a field to the west. They jumped out of the field closest to College Road North. One female had glued her right hand to the road but the others were all just sat on the road with two banners stating PLANT BASED FUTURE- ANIMAL REBELLION. At the same time 7 protesters climbed on top of one of the two lorries and 2 climbed on top of the other using telescopic ladders. Other protesters attempted to join them but were physically prevented and removed by police conducting preventative patrols. One of these protesters then joined the 5 on the ground, bringing their number up to 6.

Various ladders were seized as well as an arm tube, bolt croppers and a rucksack containing a drill from by the group on the ground.

**OFFICIAL-SENSITIVE**

Whilst officers were dealing with this, a white Luton van CT19 WTN (R/O SIXT rental Langley Key, Langley), driven by Bryan MONGELLI, [REDACTED] arrived and attempted to block the road next to the two lorries. The van contained one other male and police persuaded them to move the van out of the way, but they then produced an arm tube which they used to sit in the road, back towards the A41 exit, claiming they were now locked on inside. Within the van on the dashboard was a white A5 piece of paper with the following:

1: [REDACTED]

2: COLLEGE ROAD.

Officers were deployed to address number 1 but nothing obvious was seen. There is a layby outside but the occupant was spoken to. This is just a normal residential house and the occupant stated that no-one had stayed there overnight and he is not supportive of their campaign.

Reports came from security that 2 people had been seen inside the site and police were despatched to investigate. On arrival, it was found that 4 people, had climbed up on to the top of milk silo's within the site and were in the process of donning harnesses and attaching themselves to the railings. They had access via walkways to 4 silos in a row. One of which was found to be empty, but the other 3 had a total of 640,000 litres of milk which, due to the protesters being able to deposit things within the silos via vents at the top, would have to be destroyed.

Also within the site were 7 milk tankers that had earlier arrived and been emptied. 2 of these now contained 2 protesters on each and 2 others had one protester on each. Believed to be 5 females and 1 male. It was also found that lorry tyres on several of the lorries had been burst and drill bits and a drill were found nearby. It is believed that they have used the drill to drill the tyres. It is believed that 12 tyres over 5 lorries were damaged. At approximately 05.15hrs, a white Transit minibus DPC 312 (R/O DPC Sales and Service Limited, Haywards Heath, West Sussex) was seen travelling along Lower Icknield Way from the direction of Aston Clinton towards the A41 and Tring. The minibus was empty and only had the driver in it. Due to this it was not stop checked, but in hindsight, may well have been involved in dropping off the protesters in the area who then made across the fields to the site.

PROTESTERS ON THE GROUND:

6 protesters were sat on the road in front of the lorries. One female glued her right hand to the road. These 6 were arrested for obstructing the highway.

The six who were sat on the ground in front of the lorry were the following:

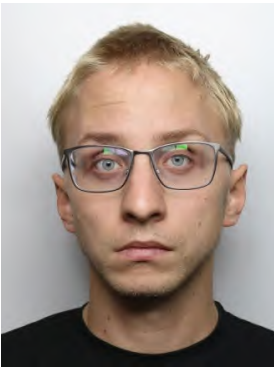

**XPO LORRIES:**

The rear lorry had 2 persons on top who initially were not locked on in any way. At one point a smoke grenade was thrown to a female on the rear lorry and these were then set off simultaneously, seemingly for publicity purposes. When protest removal officers approached to remove them, they then went into an arm tube.

All 9 protesters from the lorry were arrested for Vehicle Interference and Obstructing the Highway. These persons were:

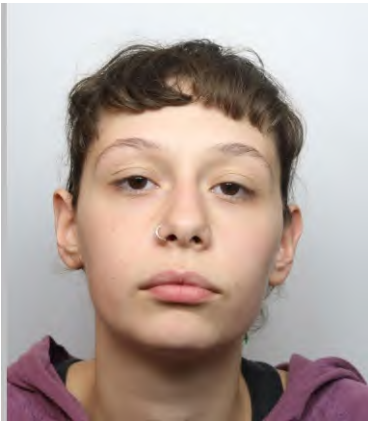

**MILK TANKERS:**

7 tankers were parked up in a delivery point. 2 pairs of females climbed on two of the lorries and sat directly on the top. 1 female climbed on another lorry and a male climbed on a fourth lorry. They all sat with ANIMAL REBELLION flags on top of the lorry. The male gave officers the name of Rob. He appeared to be an experienced protester who was willing to talk about the cause but not give any other details. The females appeared to be not a proficient as they were regularly complaining of being uncomfortable and not able to lie in situ on the tankers. Again, none of these protesters locked themselves on in any way, but as they were approached by protest removal, 5 of the 6, glued themselves on to either their own hands or the tanker roof. Rob did a poor job and his hands came unstuck almost immediately.

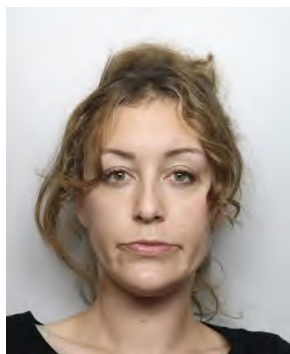

SILOS:

4 protesters, 2 male and 2 female, managed to scale a milk silo to the south-east of the site. They spent the day, singing songs and walking around the 4 silos they had access to and appeared to make make-shift seats using hessian straps across the tops of the access ladders. A windbreak shelter was also constructed. No banner was unfurled from the top and it is believed this was lost or did not make it to the top. Again as protest removal officers approached the top of the silo, 2 of the protesters sat on the makeshift seats and glued themselves. One glued his hand to his foot on the ladders itself. When PRT de-bonded his foot from his hand, he then reached in and got glue from his pocket again and did it again. As PRT were below him they couldn't prevent this. Due to this PRT ended up cutting safety netting on the ladder, to climb out and round him so they could then get to the top of the silo and work on him from the top.



# Royal Sheep Rescue: Animal Rising Free Animals From Sandringham Estate



- Yesterday at around 20:00, 3 women entered the grounds of Appleton Farm on royal land and rescued 3 lambs. It is expected that shortly these lambs would've been sent for slaughter [1].
- This morning at 8:00, after it was confirmed the sheep were safe, the women handed themselves into police at Windsor, holding placards with photos of the animals on them and slogans including "I rescued the King's Sheep" and "This is how we love animals".
- Animal Rising says this action was taken to continue the national conversation about our broken relationship with other animals and nature that began in April when the group disrupted the Grand National at Aintree.

Supporters of Animal Rising have rescued 3 sheep from the royal's Norfolk estate in what marks the first of the group's high-profile "open rescues" this summer [2]. The lambs named Sammy, Sunny, and Sooty have been taken to safety - away from the harms of animal farming.

Sarah Foy, 23, one of the women said:



“Like anyone, animals want to live out their lives safely and without being used or exploited. Sadly that is not the case here at Sandringham, or anywhere they are used in our food system. That is exactly why we rescued 3 sheep today - three beautiful lambs who’ll now live their lives to the fullest. We urgently need a national conversation about our relationship with other animals and nature.

The Royal Family could be leading the way in this; they own land around twice the size of Greater London. It would be an incredible statement for them to fully commit to the transition to a safe, secure, plant-based food system and a rewilding programme. Mending our connection to animals is vital in tackling the climate and nature crises.”

The action comes after just this week The Guardian released an article suggesting Prince William, alongside his father, was proving to be a poor custodian of Dartmoor land because of land degradation due to animal grazing [3]. Around 16% of UK land is dedicated purely to sheep grazing, whilst providing less than 1% of dietary calories. Furthermore, only 12% of UK land is forest [4].



In 2018, comprehensive research from the University of Oxford showed that 76% of the land currently used for food production would be freed-up by a global transition to plant-based production [5]. This land could be rewilded and begin carbon drawdown, mitigating the worst impacts of climate breakdown. A 2019 Harvard University report on UK farmland and food production from Helen Harwatt and Matthew N. Hayek also concluded that the UK would be carbon-negative if it completely transitioned to a plant-based food system [6].

Animal Rising is a social movement to create a new relationship with all beings and give us a chance for a safe ecological future. The group primarily calls for the transition to a secure and sustainable plant-based food system, alongside a mass rewilding programme.

# Animal Rebellion activists arrested after disrupting platinum jubilee event on Mall

Animal rights activists linked to [Extinction Rebellion](#) have been arrested after disrupting the start of platinum jubilee celebrations by storming the Mall during the trooping the colour parade.

Scotland Yard said officers made several arrests after the protesters jumped over barriers lining the Mall and confronted marching Grenadier Guards with leaflets demanding an end to hunting on royal land.

Animal Rebellion said 25 of its supporters disrupted the parade due to “the crown’s inaction on the climate emergency and their continued support for meat, fishing, and dairy”.

In a tweet showing the protest, Animal Rebellion said: “Animal Rebels disrupt the Queen’s Platinum Jubilee celebrations demanding that Royal Land is Reclaimed

A group of protesters were dragged by police out of the path of a military band as they marched along at about 10.10am.

Video of the incident showed at least eight protesters leaping the barriers to the Mall. At least two protesters sat on the tarmac as a military band stepped around them.

Videos and photographs also showed activists being pinned to the ground by police very close to marching guards taking part in the trooping the colour parade.

The Metropolitan police said the arrests were public order related, for highway obstruction. The force said on Twitter: "Thank you to the crowd who showed their support by clapping our officers who returned to their post after dealing with the incident swiftly."

Last year, [Animal Rebellion daubed red paint on the fountain](#) outside Buckingham



Palace, accusing the Queen of having “blood on her hands”. The group campaigns against the use of crown lands for hunting and animal agriculture, as well as the Queen’s attempts to have her land exempted from an initiative to cut carbon emissions.

Beau King Houston, one of those taking action, said: “The royal family has had decades to lead the way on a just transition to plant-based farming and has failed to do so. This transition is common sense and simple, we all win.”

Robert Gordon, a spokesperson for the group, said “These jubilee celebrations are set to cost the taxpayer tens, if not hundreds, of millions of pounds. All whilst we are struggling through the cost of living crisis and families across the country are increasingly reliant on food banks.”

The police and the royal parks urged people to avoid the area around Buckingham Palace as viewing space was full.

The royal parks Twitter account wrote: “Crowds have flocked to St James’s Park for Trooping the Colour and public viewing areas are now at full capacity. Please do not head to St James’s Park but enjoy the Jubilee celebrations elsewhere.”

The Metropolitan police events account tweeted: “The viewing areas in central London for the Queen’s Platinum Jubilee celebrations are now full. To avoid the disappointment of not being able to enter the viewing areas please avoid the area.”

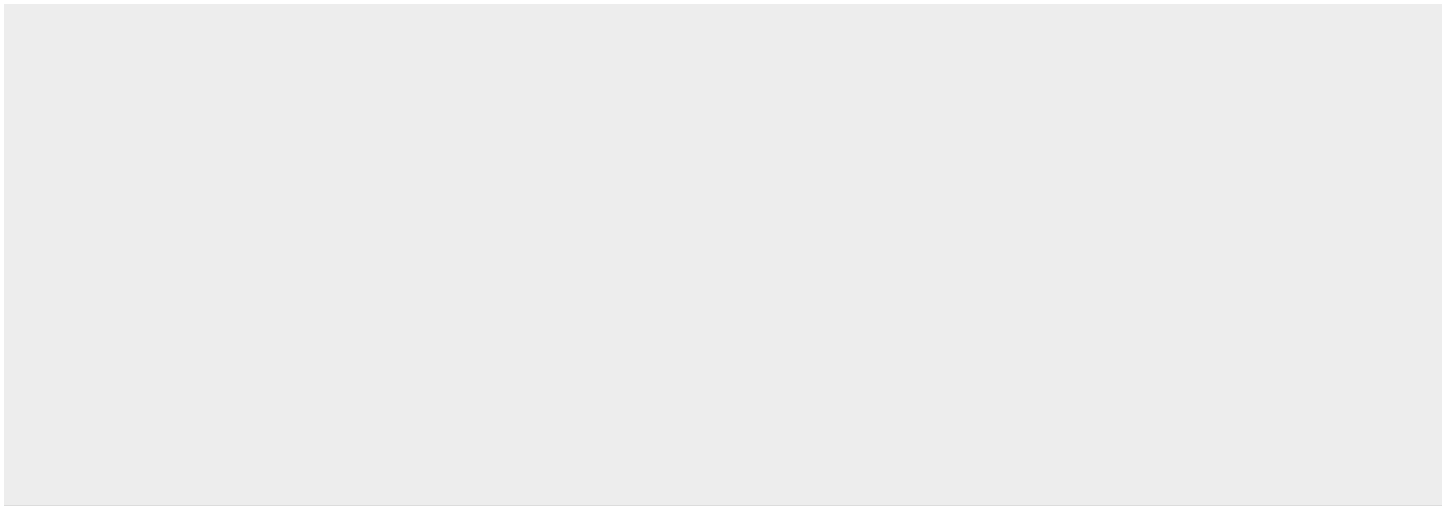

- 25 supporters of Animal Rebellion have disrupted the 'Trooping The Colour' event as the Queen's procession made its way towards Buckingham Palace.
- They are doing so due to the Crown's inaction on the climate emergency and their continued support for meat, fishing, and dairy, a leading contributor to climate breakdown [1].
- The Crown is one of the largest landholders in The UK [2] and has had decades to transition to plant-based farming and rewilding but has chosen not to.

During the opening of the Platinum Jubilee weekend, Animal Rebellion disrupted the royal procession on Pall Mall. This comes after the group dyed the Buckingham Palace fountains red last August [3]. The group are urging for an immediate transition to a plant-based future and rewilding.

Beau King Houston, amongst those taking action, has said **"The Royal family has had decades to lead the way on a just transition to plant-based farming and has failed to do so. This transition is common sense and simple, we all win. 76% of currently farmed land could be rewilded and absorb carbon from the atmosphere. This would restore nature, spare billions of animals, and present a solution to the climate emergency, all in one act."** [4]

This action comes as a response to Royal disregard for all life. Since Animal Rebellion last highlighted Crown complicity in the climate emergency, the necessary changes to Royal land have not happened. February's IPCC report stated, "Any further delay in concerted anticipatory global action on adaptation and mitigation will miss a brief and rapidly closing window of opportunity to secure a liveable and sustainable future for all." [5]

By refusing to make the necessary changes to Royal land, the Crown is showing it does not care for millions across the UK and billions of the most vulnerable across the planet. They have also come under fire for blocking construction of renewable energy sources [6].

Robert Gordon, a spokesperson for the group, said **"These jubilee celebrations are set to cost the taxpayer tens, if not hundreds of millions of pounds. All whilst we are struggling through the cost-of-living crisis and families across the country are increasingly reliant on foodbanks. Instead, this obscene amount of money could have been used to provide instant food security and kick start a plant-based future where no child is left hungry or terrified by climate collapse. We must reclaim royal land for this."**

A global shift to a plant-based food system would sequester more than 300 gigatonnes of carbon dioxide, effectively halting increase in atmospheric greenhouse gasses for 30 years [7]. Rewilding the freed-up land would not only offer carbon drawdown but would also play a vital role in repairing the biodiversity crisis [8].



**The action today comes as part of Animal Rebellion's demands for a plant-based future, which were announced on Monday 23rd of May [9]. The group is urging for wholesale governmental support for a transition to a plant-based food system and programme of rewilding that will secure a future for generations to come.**

Animal Rebellion is a mass movement using nonviolent civil disobedience to call for a just, sustainable plant-based food system.

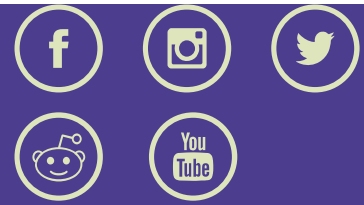

- In the early hours of this morning, Animal Freedom Movement (AFM) occupied the Marshall BioResources' (MBR) puppy farm in Huntingdon, Cambridgeshire, for the second day in a row.
- The group, a project supported by Animal Rebellion, successfully liberated 5 beagles, who otherwise would have likely been used and eventually killed in animal testing experiments.
- The Animal Freedom Movement first took action yesterday against MBR Acres in a mass trespass, demanding that MBR shut down the facility and rehome the dogs. They also called on the British government to commit to phasing out all animal testing and sale of animal-tested products by 2025.

Dr Lindsay Marshall, biomedical science advisor to the Humane Society International UK, has recently stated "*The UK cannot expect to have world-leading science innovation whilst we rely on failing animal-based research methods that are rooted in the past.*" [1]

Earlier this morning, Animal Freedom Movement accessed sheds containing young beagles and liberated 5 dogs. This marks a significant escalation in the nonviolent direct action (NVDA) against MBR Acres and Animal Testing in the UK.

In 2020, 2.88 million instances of animal testing were recorded in the UK [2]. 4,340 of these were carried out on dogs, with 4,270 of these on beagles like those bred by MBR Acres. The procedures often result in vomiting, internal bleeding, organ damage and seizures; the tests can last for months, after which the dogs are killed.

**AFM urge anyone who supports an end to animal testing to attend a peaceful demonstration outside The Home Office on Monday June 27th at 4.30pm.**

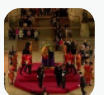

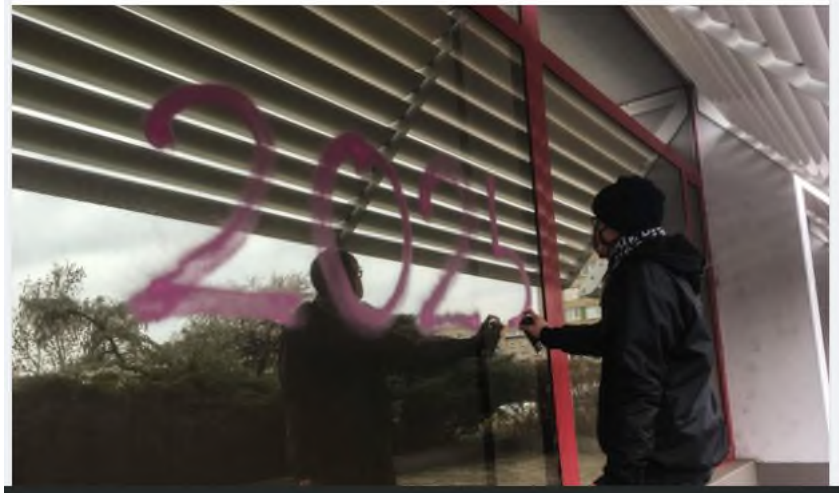

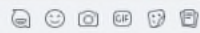

# Dartford Crossing: Two jailed over widespread disruption

Two men have been sentenced after causing widespread disruption across the South-East when they dangerously climbed the QEII Bridge at the Dartford Crossing.

Morgan Trowland and Marcus Decker began climbing the bridge stanchions in the early hours of 17 October last year.

The men then eventually climbed to about 200ft above the water and remained suspended over the carriageways. Their actions led to the bridge being closed for 41 hours.

They stated their actions were in protest, but those actions caused disruption to hundreds of thousands of people on the M25 and surrounding roads, many of whom lost out on salary, missed significant family occasions or could not access medical help when it was urgently needed.

Both men were removed from the bridge by specially trained officers on the afternoon of 18 October.

Officers had trained on a specialist raised platform at a nearby fire station before it was brought to the bridge.

Once they were safe, both men were arrested on suspicion of causing a public nuisance and subsequently charged.

They denied the charges but were found guilty of the offence at Southend Crown Court. They appeared at the same court today, Friday 21 April, to be sentenced.

Trowland, 40, of Drummond Way, Islington, and Decker, 34, of no fixed address, were sentenced to three years and two years and seven months respectively.

## "Actions were dangerous and disruptive"

Detective Chief Inspector Louise Metcalfe, who oversaw our investigation, said:

"Trowland and Decker's actions were completely unacceptable. They were dangerous and they were incredibly disruptive.

"We know they saw their actions as protest - they were not. They caused danger and disruption to many.

"Thankfully, our specially trained officers were able bring the incident to a safe conclusion."

DCI Metcalfe added:

"I would also like to thank everyone involved in this investigation - from those officers who worked at a dangerous height to bring both men down, to the dedicated team of investigators who were responsible for building the overwhelmingly strong case against both men.

"I have seen first-hand the tireless work that the team has put in to secure these convictions. Their work to secure justice simply cannot be underestimated."

## Dartford Crossing bridge climber released on bail, however now faces threat of deportation

Marcus Decker, one of two men imprisoned for scaling the QE2 Dartford Crossing in October of 2022, has been released on bail, however now faces a potentially lengthy battle to avoid deportation. Marcus took action to demand that the UK government immediately halts all new licensing and consents for fossil fuel exploration and extraction. [1]

After climbing 60 metres (200ft) up the Queen Elizabeth II Bridge and releasing a Just Stop Oil banner, Marcus and fellow Just Stop Oil supporter Morgan Trowland remained on the bridge for almost 40 hours before being removed by police. [2]

in the UK. However, he now faces automatic deportation and potentially a prolonged legal battle for him to remain in the country with his partner and two step-children. [3]

On release from HMP Highpoint, Marcus addressed media outside with the following statement:

*"It's been 490 days since I have not been in either handcuffs or behind barbed wire. Today, I'm overjoyed that I can finally embrace my love Holly and the children again, and go home with them. Unfortunately, that doesn't necessarily mean I will be able to stay with them forever, as I've been released on immigration bail and so the deportation struggle continues, which is devastating.*

*What a journey it has been since my friend Morgan and I climbed the cables of the Queen Elizabeth II bridge, in October 2022, when I followed my conscience to enact an entirely peaceful act, based on my informed understanding of the best available science, which details clearly the dire predicament we all find ourselves in.*

*I chose to attempt to call for some 'real justice' as the remarkable Chris Packham recently put it to me so eloquently. I'm appalled and despairing that despite the crystal clear facts and frightening evidence of our systematic hurtling towards an unliveable world, and with already hundreds of thousands of avoidable deaths every year, the governments of the world (very much including our own here in the UK) are continuing to throw more fossil fuels onto the fire by licensing new oil and gas, whilst delaying real climate action like insulating our homes and decarbonising the food sector.*

*With tipping points in the climate system dangerously close and complete societal breakdown therefore on the horizon during my lifetime, it's obvious that many more people will be taking action as our situation worsens. I myself will refrain from breaking the law and will concentrate on the campaign to stop me from being separated from my family yet again.*

*I am distressed that my action above the Dartford crossing caused inconvenience and negatively affected many people on the day, and I do want to apologise for it. I have accepted my sentence in the knowledge that my actions were an attempt to minimise a much greater harm that is currently being imposed on our communities. I do however feel deportation would be a lifelong double punishment, not only for me but also for Holly and the children, something which I feel would be completely disproportionate.*

*I'd like to thank those who stuck by me, everyone who has supported me directly and indirectly throughout my imprisonment, all those that make prison more bearable, and those that have written to me from around the globe. My gratitude goes out to all those in this country and around the world who continue to risk their liberty, or even their lives for a livable future. Of course, I'd also like to thank my family, most of all my dear Holly. Thank you very much."*

A petition calling for Marcus to remain in the UK has attracted over 154,000 signatories and in January a letter signed by around 600 leading actors and musicians, including Bob Geldoff and Oliva Colman, was delivered to the Home Office calling for them to withdraw the deportation order issued to Marcus. Marcus's partner Holly commented on his release:

*we've received from so many has enabled us to stay strong throughout.*

*I am forever in awe of Marcus, who even during the most difficult and cruel moments in prison, stayed calm and focused. His desire to help those around him at every stage never wavered and I believe he used his time inside as well as he possibly could, starting a choir for other prisoners, playing the piano for church services and helping run the chess club.*

*Marcus has apologised to all those who were badly affected by being stuck in traffic on the days of his action and I can assure you that he is truly sorry for that. I hope you can find it in your hearts to forgive and understand why his conscience led him to try and act on behalf of all those dying as a result of the climate crisis right now and for all our children who will ask us what we did to try and stop it."*

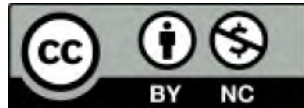
